We also adhere to recruitment and employment practices that are fully compliant with UK law, ensuring fairness and transparency.

## Ongoing commitment

DM is dedicated to continuous improvement in corporate social responsibility, particularly focusing on environmental impact, labour and human rights, ethics, and sustainable procurement. While we assess our risk as low given our operations and geographical focus, we are committed to regularly reviewing and enhancing our policies and procedures to quickly identify and mitigate any potential risks.
